Biman is expecting your kind attention for following:

Free baggage allowance:

Business Class

Checked Baggage: 50 kg will be 02 pieces.

The sum of the 3 dimensions (length + breadth + height) must not exceed 62 inches or 158 centimeters for each piece.

The maximum weight permissible for a single piece of baggage is 30 kgs.

Each adult/child passengers are permitted one piece of carry-on baggage, that may not exceed 20 x 15 x 10 inches (56 x 36 x 23cm) and must weight no more than 10kg for business class.

Economy Class

Checked Baggage: 40 kg will be 02 pieces.

The sum of the 3 dimensions (length + breadth + height) must not exceed 62 inches or 158 centimeters for each piece.

The maximum weight permissible for a single piece of baggage is 30 Kgs.

Each adult/child passengers are permitted one piece of carry-on baggage,, that may not exceed $20 \times 15 \times 10$ inches ($56 \times 36 \times 23$ cm) and must weight no more than 07×10 kg for Economy class.

Infants in all Classes

Free Baggage Allowance: 10Kgs limited to one piece.

In addition they are entitled to one collapsible stroller/carrycot/infant car seat subject to availability of space.

Excess Baggage Charges

If FBA baggage weight exceeds maximum limit, then excess baggage charge will be GBP 8.00per kg.

Charges for additional extra piece beyond above limit will be as follows;

I) Weight up to 15 kg GBP 80.00 ii) Weight up to 20 kg GBP 95.00 iii) Weight up to 30 kg GBP 110.00

Request/phone call for extra baggage other than free baggage allowance/size without payment should be avoided.

Other important information:

Please ensure passing of all related information while ticketing including both way mobile number along with email.

VIP/CIP request should be properly added while issuance of ticket with proper designation/rank/position of passenger .As such respected passenger or his representative will book/issue ticket showing supporting ID/papers.

Additional/special service (if any) should be requested and deposition of fee/charges (if applicable) in advance.
