Oral and Maxillofacial Surgery with 2 seats
Inspector Observations:-
There is adequate experienced teaching staffs.

There is adequate equipments available.
There is adequate auxillary staffs.
Though the dental college and dept. of OMFS has a memorandum of understanding with KMCH Hospital Medical College and KMCH Hospital nearby (2.5km) the major operation work done in KMCH Hospital which is not in the campus does not co-relate to the records (Major OT) of the dental college. There are no records of the major work done in KMCH hospital register. As per college authorities patients from dental college are transferred to KMCH Hospital to be operated which is a private corporate hospital. KMCH Medical College & Hospital is not in the dental college campus. Post graduate students appear to have observed/assisted major cases only in ESIC Hospital where they have peripheral postings. The peripheral postings shown as completed by PG's cannot be verified there are no completion certificates from the allied medical departments.
Library adequate books and e journals are satisfactory.
Minor work done in PG clinic appears to be unsatisfactory .
Salary drawn by staffs are not as per UG norms.
Bank Statements or passbooks were not furnished by college authorities to verify salarty statements or record of salaries depost.
