# THE FOLLOWING PROCEDURES AND TARIFF CODES ARE ASSOCIATED WITH THE IMPORTATION OF VEHICLES TO THE CAYMAN ISLANDS



## THE DECLARATION PROCESS



### **Importing vehicles into the Cayman Islands**

The Cayman Islands allows the import of new and used vehicles, provided the vehicle meets applicable standards, safety and emissions requirements. There must also be acceptable proof of entitlement to the vehicle.

This following gives a step-by-step overview of the procedures for importing a road vehicle into the Cayman Islands. The procedures involve multiple government agencies so you should familiarise yourself with each agency's requirements before importing a vehicle into the Cayman Islands.

### Before importing

### Conduct research

Before importing a road vehicle, consider the costs of importation such as:

- pre-shipment costs (e.g. steam cleaning for removal of any materials that may pose a risk)
- What costs are involved? (e.g. shipping, delivery, taxes, Customs duties, registration and insurance requirements, etc.).
- What are the time frames involved for completing the necessary arrangements?
- What documentation do I need?
- What does each government agency require?
- Do I need to use a broker? (What are the customs brokers' charges?)
- What are the port charges?
- What risks are involved with importing a vehicle?
- What about hybrids and electric vehicles?

**Note:** If you wish to import a hybrid vehicle or a plug-in electric hybrid vehicle you must be able to show it has been certified to meet the appropriate emissions and safety standards,

just as you would for a petrol or diesel vehicle. An Electric Vehicle (EV), powered wholly by electricity, will also need to meet the appropriate safety standards.

### Once the decision has been made to import a vehicle:

### Arrange shipping of the vehicle

- Before shipping, ensure vehicle is steam cleaned inside and outside to remove any
  materials that may pose a risk (while it is not a requirement, it may be a beneficial
  option, especially for used vehicles);
- For individuals importing vehicles from the United States, you will need to get the
  vehicle to the Port of Miami or Tampa, clear US Customs and book the car on the
  next ship sailing to Cayman. Auto dealerships who do this on a regular basis, are
  familiar with the clearance process.
- For individuals importing vehicles from Japan, Korea and Singapore, they will come through the port in Jamaica and then on to Cayman.

### Before the arrival of the vehicle:

### Register for a CBC Customs Online Account

- Create an account in <u>COLS</u> (if not already registered)
- Complete the online application form at <a href="https://Online.Gov.ky/COLS/Faces/Home">https://Online.Gov.ky/COLS/Faces/Home</a>
- Receive email with approval and Trader Identification Number (TIN) attached

### After the arrival of the vehicle:

### **Get Customs clearance**

Once your car has landed at the port in Cayman, the shipping company will notify you. You can hire a customs broker to help you with this process, as it can be fairly complicated and time consuming. If you are doing it yourself however, the next steps are as follows:

- <u>Collect paperwork</u> from the shipping company and pay shippers;
- Lodge an import declaration in the Customs Online System (COLS);
  - *Note*: You must provide evidence that you're lawfully entitled to the possession of the vehicle. You'll need original documents (faxed or photocopied documents are not sufficient), establishing a link to the last owner (e.g. deregistration papers, certificate of registration, invoices, wire transfers proof, bills of sale, receipts etc.). You'll need certified translations of any documents that are not in English.
- Pay Customs duty. Once the duty has been determined, go to Customs and Border Control Headquarters and pay the duty on your vehicle. The import duty is calculated on what is known as CIF. This is the Cost of the car plus the Insurance premium for its journey by ship, plus the sea freight charges. Duties range from to 0% 42% depending on the type and value of your vehicle.
   All pick-up trucks are rated at 29.5%;
- Pay a Special Waste Fee of CI\$250 for future car disposal. For motorcycles, the fee is CI\$75;
- <u>Used automobiles and other mechanically propelled vehicles</u> of not more than CI\$12,000 C.I.F. value, are charged an <u>Environmental Tax</u> of \$1,000. These fees are collected on behalf of the Department of Environment (DOE).

- Go to the Port Authority and pay port charges based on the weight of your vehicle;
- <u>Obtain car insurance</u> (you will need proof of insurance before collection of the vehicle);
- <u>Pick up your vehicle</u> from the Port Authority.

### Registration

 Once customs clearance has been completed your vehicle must be checked, registered and licenced at the Department of Vehicle and Drivers' Licensing (DVDL) before it can be legally used on Cayman's roads.
